The District will continue to follow Article XII-Class Size. No teacher shall exceed the current maximum number of 175 students per teacher.





Article XI 1.i. Personal Necessity - Paid

K. Personal Necessity Leave - Paid

1. i. Other Emergencies. A matter of a compelling emergency nature which is not covered by one of the above reasons and which cannot be reasonably disregarded, and is of such severity that the unit member is required to attend to it during assigned hours of service. The District shall provide unit members with five unchallenged use of "Other Emergencies" leave. The use of two days combined shall not precede or follow a holiday unless approved by the immediate supervisor. Unit members shall, whenever possible, give 24 hours notice of such emergency.
